RE: VERIZON WIRELESS DISCOUNT

It has come to our attention that Verizon Wireless is requiring something different now in order to obtain the government employee discount.

The first page that follows, **“Nationwide Single-Line and Family SharePlan Calling Plans,”** is information about the program. If you already receive the discount, you do not need to do anything!

If you are trying to get the discount applied to your Verizon Wireless service, there are 3 ways to proceed:

- 1) You can sign up online if you have an email address at work (see Internet instructions flyer, **“Join America’s Most Reliable Wireless Network”**).
- 2) If you do not have an email address at work, you can fill out the **Employee End User Form** with the proof of government employment document (employee ID or pay stub – see Employee End User form for details) and fax or email it to them.
- 3) You can also now go to a Verizon Wireless store with proof of government employment to have them set it up.

Sorry for the inconvenience if you tried to do this in a store recently and could not!

If a review of your employment status reveals that you are not, or are no longer, an employee of your organization, Verizon Wireless reserves the right to remove this discount and move you to a commercially available calling plan or to a non-discounted service plan for the remainder of your line term commitment.
