Sweepstakes Official Rules

NO PURCHASE OF ANY KIND IS NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

BY ENTERING THIS SWEEPSTAKES, ALL PARTICIPANTS AGREE TO BE BOUND BY THE FOLLOWING OFFICIAL RULES AND ALL DECISIONS OF THE SWEEPSTAKES SPONSOR, WHICH ARE FINAL IN ALL RESPECTS.

- **Sponsor:**
 - This Sweepstakes is sponsored by **Muskingum Watershed Conservancy District** ("Sponsor"), whose principal place of business is 1319 Third St. NW New Philadelphia, Ohio 44663.
 - Sponsor is the final judge on any decisions made regarding the Sweepstakes.
- **Prizes:**
 - **First Place Prize - \$200.00 gift card.**
 - **Second Place Prize – \$150.00 gift card.**
 - **Third Place Prize – \$100.00 gift card.**
 - **First 200 entries receive a custom MWCD medallion.**
 - **Participants with three entries from three different parks will receive a walking stick.**

Prizes will not be mailed to participants. Winners must make arrangements to pick up prize at any MWCD Park/Marina or Main Office Facility.
- **Sweepstakes Period:**
 - Participants can enter the Sweepstakes via electronic entry beginning 8:00 a.m., Friday, May 24, 2024 through 11:59 p.m., Monday, September 2, 2024, at www.mwcd.org/capturethecanvas.
- **Eligibility:**
 - The Sweepstakes is open to legal residents of the fifty United States and the District of Columbia, except where prohibited, who: (a) are 18 years of age or have reached the age of majority in their jurisdiction of residence at the time of entry, whichever is greater, and (b) are legally able to work in the United States. No purchase is necessary.
 - Employees and agents of the Muskingum Watershed Conservancy District and their immediate family members (mother, father, sons, daughters, and spouse, regardless of where they reside) and household members of the employee or agent, whether or not related, are not eligible to enter the Promotion.
 - This is a U.S. promotion only, governed by Ohio law except with regard to its conflicts of law provisions. Any action under this promotion shall be venued in Tuscarawas County, Ohio.
 - This promotion is prohibited in Florida, New York, Rhode Island, and anywhere else prohibited by law.
- **How to Enter:**
 - **NO PURCHASE NECESSARY.**
 - Students from local schools have created unique works of art that have been placed in trees along MWCD trails at Atwood, Tappan, Charles Mill, Pleasant Hill, and Seneca Lake Parks.
 - Using the trail maps available at www.mwcd.org/capturethecanvas or at the park office, locate the artwork in trees along MWCD trails. Take a picture of the artwork and upload it to the website. Provide your name, address, zip code, email, and phone number and, agree to be bound by the contest rules.
 - Up to three (3) entries per person. Each entry must be from a different park. The odds of winning depend on the number of valid entries.
 - By entering this Sweepstakes, entrants agree to be bound by these Official Rules and all

- decisions of the Sweepstakes Sponsor, which are final in all respects.
- Winners will be chosen from a random selection of the entries gathered from individuals who have entered the Sweepstakes.

- **Winner Selection:**

The Prize drawing will take place on September 9th at 1:00 PM EST for the First, Second, and Third Place prize. Winners will be chosen from a random selection of the entries gathered from individuals who have entered the Sweepstakes. Only one winner of the First, Second, or Third Prize per household is permitted.

- **General Conditions:**

- Invalid or ineligible entries are excluded from Sweepstakes consideration. Individuals that submit more than three entries will be disqualified.
- Potential winners need not be present at the drawing on September 9th, 2024. In the event that a potential winner does not respond by September 15th, 2024, an alternative prize winner will be selected at a date chosen by MWCD.
- Failure to comply with these requirements may result in Sweepstakes disqualification and selection of an alternate winner.
- Sponsor reserves the right to change, cancel, shorten, or extend the promotion at any time without notice.
- Void where prohibited by law. All federal, state, and local laws and regulations apply.
- Prizes are not transferable and second and third prizes cannot be substituted for cash value.
- Walking Sticks and MWCD medallions must be picked up at location designated by Sponsor.

- **Permissions**

- Except where prohibited by law, entry constitutes permission to use winners' names, hometowns, and likenesses for online posting, and/or any advertising and publicity without additional compensation. Winners may also be required to sign and return a release of liability, declaration of eligibility, and, where lawful, a publicity consent agreement, as conditions of receiving a prize. Muskingum Watershed Conservancy District and the employees, officers, directors, agents, and representatives of Muskingum Watershed Conservancy District are not responsible for and shall not be liable for: (i) late, lost, delayed, damaged, misdirected, incomplete, illegible, or unintelligible entries; (ii) telephone, electronic, hardware, or software program, network, Internet, or computer malfunctions, failures, or difficulties; (iii) errors in transmission; (iv) any condition caused by events beyond the control of Muskingum Watershed Conservancy District that may cause the contest to be disrupted or corrupted; (v) any injuries, losses, or damages of any kind caused by a prize or resulting from acceptance, possession, or use of a prize, or from participation in the contest; or (vi) any printing or typographical errors in any materials associated with the contest. Except where prohibited, as a condition of participating in this promotion, entrant agrees that any and all disputes that cannot be resolved between the parties, and all claims and causes of action arising out of or connected with the promotion or any prize awarded, or the determination of winner shall be resolved individually, without resort to any form of class action.
